Devolution of municipal functions of the Urban Environmental Engineering Department to the Urban Local Bodies.

Reference :

Cabinet Decision No: 91/7 Dated: 30.05.2005.

Government Order No: 188-HUD of 2005  
Date: 03.-06-2005.

It is hereby ordered that the municipal functions presently being performed by the Urban Environmental Engineering Department shall be transferred to the urban local bodies along with its staff, assets and funds, as detailed below:

- a) UEED Circle No.1 Srinagar along with its three divisions namely, the City Drainage Civil Division Srinagar, Sewerage and Drainage Division II Srinagar and City Drainage Mechanical Division Srinagar (with two out of three sub divisions) shall be transferred to Srinagar Municipal Corporation to deal with construction and maintenance of drainage system of Srinagar city.
- b) The Data Collection & Quality Control Division Srinagar shall be renamed as Town Drainage Division Kashmir and transferred to the Directorate of Urban Local Bodies Kashmir to look after the construction and maintenance of drainage works in the towns of Kashmir Division other than Srinagar city.
- c) Sewerage & Drainage Circle Jammu along with Sewerage & Drainage Division (West) Jammu shall be transferred to Jammu Municipal Corporation to deal with construction and maintenance of drainage system of Jammu city. It shall continue to look after the Talab Tiloo Sewerage Project till the Water and Sewerage Board is set up.
- d) Sewerage & Drainage Division (East) Jammu shall be renamed as Town Drainage Division Jammu and transferred to the Directorate of Urban Local Bodies, Jammu to look after the construction and maintenance of drainage works in the towns of Jammu Division other than Jammu city.
- e) Till such time Water and Sewerage Boards for the two cities are set up the Chief Engineer UEED shall exercise overall technical control of all drainage and sewerage projects. The UEED Circle II Srinagar and Sewerage & Drainage Division I Srinagar shall look after the sewerage projects of Srinagar city along with one sub Division of City Drainage Mechanical Division Srinagar.
- f) All State sector Plan and Non-Plan funds for construction and maintenance of drainage works in Srinagar and Jammu cities shall be transferred to the Municipal Corporations of Srinagar and Jammu respectively.
- g) All District Sector Plan and Non-Plan funds for construction and maintenance of drainage works in other towns of the Kashmir and Jammu Divisions shall be

transferred to the Directorate of Urban Local Bodies Kashmir and Directorate of Urban Local Bodies Jammu respectively.

- b) The Plan and Non-Plan funds for revenue expenditure shall be transferred to the concerned Municipal Corporations/ Directorate of Urban Local Bodies to whom the Circles/ Divisions have been transferred.
- i) The existing arrangements of drawing and disbursing powers with the Circles/ Divisions and operations through the Treasuries shall continue till further orders.
- j) All movable and non-movable assets of the Urban Environmental Engineering Department shall be transferred to the concerned Municipal Corporations/ Directorate of Urban Local Bodies to whom the functions shall be transferred.
- k) The PHE and I&FC Department would continue to manage the cadre of engineering staff who will be on deputation to the Municipal Corporations and the Directorates of Urban Local Bodies.
- l) The non-engineering staff on deputation from other departments shall similarly be on deputation to the Municipal Corporations and the Directorates of Urban Local Bodies.
- m) The status and seniority of the staff borne on the cadre of the UEE Department shall be decided separately by the Housing & Urban Development Department.
