However, the accord of sanction of funds is subject to the following conditions:-

- 1. The payment to institutions shall be made only in respect of the candidates who have attended the course with 80% attendance and who have been declared passed as per guidelines of SJSRY/NULM.
- 2. The payment shall be made to the institutions that are registered/recognized with Board of Technical Education/Skill Development Corporation/DOECC/VTP or any other government /Semi Government Institutions as per guidelines of Government of India.
- 3. The Institute shall provide certificates which are recognized by the government of India/State government.
- 4. The release of funds does not confer the sanction to incur the expenditure and shall be booked only after observing all codal formalities.
- 5. The funds shall be utilized on that component of the scheme only for which these have been released and no appropriation /diversion shall be made toward any other component of the scheme.
- 6. The expenditure shall commensurate with the physical progress achieved.
- 7. The CEO/PO/In charge POs shall ensure that the payment made to the institutes on account of material only against the material consumed by the trainees during the training course and no payment is made on account of Administrative/miscellaneous charges.
- 8. The JUDA/UDAK/DUDA's shall furnish the physical/Financial progress report by or before 5th of every month to this department.
- 9. The JUDA/UDAK/DUDA's shall furnish the Utilization of funds for the released funds within one month positively.
