Sanction is accorded to the release of funds to the tune of ₹100.00 lacs (Rupees one crore only) in favour of Executive Officer, Municipal Committee, Katra as Devolution of funds (Grant in Aid) 1st quarter for meeting the salary demand of the employees of the said Municipal Committee for the year 2014-15. The said release of funds is subject to the following conditions:

- The above amount shall be drawn by Director Finance, Housing & Urban Development Department from Civil Secretariat, Treasury by debit to Major Head 2217-UD Grant-in-Aid to Urban Local Bodies/Municipalities – (Non Plan) and placed at the disposal of Executive Officer, Municipal Committee, Katra by crediting the same into the official account of the said Committee i.e; S/B 0235040100000443 – J&K Bank Branch Katra.
- 2. The concerned HODs/DDOs are advised to incur the expenditure on authorized and permissible objects of expenditure only, after observing all codal formalities required under rules and no diversion of funds shall be permissible.
- 3. The funds shall not be utilized for drawl of wages/salary of illegal appointees. Any deviation shall be personal responsibility of the concerned HoD/DDO.
- 4. The expenditure shall strictly be incurred for the purpose for which the fund under GIA has been sanctioned as per SFC guideline.
- 5. Utilization certificate & detailed object wise accounts of expenditure against the funds released shall be submitted by or before 10th of the following month.
- 6. These issues with the concurrence of Finance Department conveyed vide their No. FD-VII-19(Bgt)2014-15 dated 24.04.2014.
