Sector to be utilized on approved ongoing projects/ schemes only during year 2014-15.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bills and place the same at the disposal of concerned corporations in the shape of hundies

**The release of funds is subject to the following conditions:-**

1. The release of funds does not confer the sanction to incur the expenditure which should be booked after observing all requisite codal formalities.
2. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the competent authority:
3. The funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority.
4. The funds shall not be utilized on clearance of any past liability, repair renovation & maintenance work
5. The implementing agency shall ensure that there is no overlapping of funds for the works being executed;
6. The expenditure shall commensurate with the physical progress achieved;
7. All video graphic/photographic evidence of work both shall be maintained.
8. The physical and financial progress report shall be furnished to the Adm. Deptt. well in time
9. The physical and financial progress report shall be furnished to the Adm. Deptt well in time
10. The implementing agency shall follow up the procedural mech. Of CAS-MIS system.
