Subject:-Issuance of I- Card for Street Vendors.

Whereas this department vide reference No. HUD/Plan/14/2014(AF) dated: - 18.01.2016 issued a short term tender notice and invited sealed Bids from registered units/firms (Registered with J&K Industries & Commerce Department) for printing of plastic Identity card as per the specification for Street Vendors and community organisers of different Municipal areas/ Municipal Corporation/ Municipal Committees of Jammu & Kashmir State up to ending January, 2016 and requested to send a sample of Identity Card with holder and tag in closed envelop along with the Bid document to the office of Member Secretary SUDA.

Whereas in reference to this short term tender notice, the department has received four Bids out of which only two Bids namely i. Ascent Institute of Management and Technology, Exchange Road Dangarpora Pulwama and ii. Print Xpert District Complex Road Pulwama were submitted with EMD of Rs. 5000/only for printing of plastic I- Card of Street Vendors and qualified for participation.

Whereas the Bids were opened on 10.02.2016 and it has been found that the Ascent Institute of Management and Technology has quoted lowest rate of Rs. 70/- for printing card with Holder and digitally printed neck strip along with design and photography.

Whereas the Ascent Institute of Management and Technology, Exchange Road Dangarpora Pulwama has been qualified and approved for printing I- Card with Holder and digitally printed neck strip along with design and photo of Street Vendors of different Municipal areas/ Municipal Corporation/ Municipal Committees of Jammu & Kashmir State.

Consequent upon above, M/S Ascent Institute of Management and Technology, Exchange Road Dangarpora Pulwama has been authorized to printing I- Card with Holder and digitally printed neck strip along with design and photo of Street Vendors of different Municipal areas/ Municipal Corporation/ Municipal Committees of Jammu & Kashmir State as per the sample card approved by the competent authority at the rate costing of Rs. 70/ Card subject to the following conditions:-

- The sample card has been sent to every District Urban Development Agencies (DUDA's) to ensure that the cards are supplied as per the approved sample.
- 2. In case of any complaint with regard to quality of card/ material, the SUDA/DUDA shall be free to cancel the rate contract and forfeit any payment whatever due to firm and cancel of already supplied cards.
- 3. The DUDA's shall provide the details of Street Vendors to the firm and the firm shall provide the card as per the approved design along-with photo of the Street Vendors.
- 4. The firm shall take the photographs of Street Vendors for which no extra payment shall be given to the firm.
- 5. The DUDA's shall made the requisition for release of funds on the basis of I-Card supplied by the firm.
