- iv. Release for balance work/amount shall be made in each case by the Administrative Secretary, HUDD based on physical/ financial progress and field verification thereof,
- v. That any such item/s not covered under relevant schedule of rates shall be paid in accordance with the set Codal procedures:
- vi. The NOC from other department needs to be obtained where ever required.
- vii. At the proper codal procedure, mandatory as per standing State Govt, Rules/ Regulations is followed for finalization of award of contract to entire transparency and economy.

b. Create new posts of any provided for in the Administrative Approval.
