- a. Advance drawal of 1st installment of Central Assistance of funds amounting to Rs. 158.597 Crore (Rupees One Hundred Fifty Eight Crore Fifty Nine Lakh and Seventy Thousand) only in favour of Director Finance, Housing and Urban Development Department for crediting the same into the official Bank A/C of Single Nodal Agency of AMRUT 2.0 i.e. Director, Urban Local Bodies, Kashmir bearing Account No. 0404040510000014 maintained in J&K Bank, Old Secretariat, RTO Branch, Srinagar; and
- b. Subsequent utilization of the released funds by the Implementing agencies (Commissioner SMC/JMC,DULB,J/K,CE,UEED) on the approved SWAP project of AMRUT 2.0 as per the breakup enclosed at Annexure-A to this Govt. Order.

The release and subsequent utilization of funds shall be subject to fulfillment of the following conditions by the Single Nodal Agency/Implementing agencies:-

- 1. The release of funds does not confer the sanction to incur/book the expenditure which should be booked only after observing all codal formalities and strictly with the allotment cost;
- 2. The funds shall be utilized strictly in accordance with the Guidelines of the scheme and for the purpose for which it has been sanctioned;
- The funds shall be utilized for only for projects which have been technically sanctioned and administratively accorded by the CompetentAuthority;
- 4. E-tender shall be invited, wherever applicable.
- 5. All relevant provisions of the approved scheme, GFR 2017 and economic instructions issued by the UT/Central Govt. shall be compliedwith:
- 6. The funds so released shall not be available for any re- appropriation/diversion;

- 7. All necessary instructions relating to implementation of Single Nodal Agency System issued by Department of Expenditure vide OM No. I(13)PFMS/FCD/2020 dated 23rd March, 2021 and further instructions issued till date shall be complied with regard to monitoring and utilization of funds;
- 8. The projects shall be monitored at regular intervals to ensure its completion within the scheduled time frame and also within the sanctioned cost. In no case, any cost escalation, shall be admissible/entertained;
- 9. Each work shall be 100% physically verified and third party test inspections(s) shall be conducted in respect of high value works.
- There should not be any overlapping of activities under the project withthe activities of any other ongoing schemes under CSS/CS/UT Govt. scheme;
- 11. The fixed assets created out of this grant shall not be disposed of without prior concurrence/approval of the competent authority;
- 12. All requisite legal and executive measures shall be taken to ensure that the Local Bodies augment their resources for operation and maintenance of the assets created;
- 13. The expenditure shall commensurate with the physical progress achieved;
- 14. The implementing agency shall ensure stakeholder consultations during implementation of the project. The suggestions made are to be taken care of during implementation stage. Benefits of project should adequately propagated in the public through mass awarenesscomponents;
- 15. Video graphic/photographic evidence of the works (at different stages of construction i.e. pre, post and during) shall be maintained and preserved. The photographs with geo-coordinates shall be uploaded through Proof Application;
- 16. That the DDO shall ensure that the released funds are placed at the disposal of the executing department for utilization as per the actual work done claim after due physical verification;
- 17. The Implementing Agency shall furnish the UC as per the prescribed format by 15th Oct, 2023 and also rendered Red DC Account to AG officetimely. Further release of funds will be considered after receipt of Utilization Certificate in duly signed by all concerned, along with statement showing clearly the physical and the financial progress of implementation of works in terms of percentages.
