The terms of reference of the Committee shall be to propose a comprehensive framework to regulate the disposal of immovable properties, whether residential or non-residential (commercial/office complexes/institutional assets, etc), by the subordinate entities of Housing & Urban Development Department. The framework shall also include the manner in which existing and expired leases are to be dealt with. The public convenience as well as the interests of the Government shall be kept in view while making the recommendations.

The Committee shall propose the framework/ policy keeping in view the provisions of the statutes governing these entities, the requirements of the Real Estate (Regulation & Development) Act, 2016, and the best practices prevailing in other parts of the country.

The Committee may co-opt any other member as may be considered necessary. The Committee shall submit its report and recommendations by 10.08.2023.
