Consequent to above, it is further ordered that:-

- The existing SNAs viz. DULBJ in case of SBM-Urban and CEO JUDA in case of DAY-NULM shall get their accounts audited since the inception of the SNA and share the Audit report with the Administrative Department within a month.
- 2. The existing SNAs shall immediately freeze the transactions of their respective SNA accounts. They shall handover the ID and password of the SNA accounts to the new SNAs i.e Mission Director SBM-Urban 2.0 and Mission Director DAY-NULM. Subsequently, the Mission Director and the Scheme Manager of the respective schemes shall immediately change the Agency name on the PFMS from existing SNAs to the Mission Director SBM Urban 2.0 and DAY-NULM and shall further revalidate both the accounts on the PFMS portal
- 3. Mission Director, SBM (U)'s official account No. 0110040500000063 (IFC Code JAKA0MOVING) and Mission Director, DAY-NULM official account No. 0110010200000964 (IFC Code JAKA0MOVING) shall be operationalzed by J&K Bank as SNAs of the respective schemes, as per extant rules and procedure.
- 4. The existing SNAs viz. DULBJ for SBM Urban 2.0 and CEO JUDA for DAY-NULM shall henceforth be child agencies for their respective missions for which they shall open separate zero balance accounts as per norms.
