As such, it is requested that the spelling of her name kindly be written as Ms. Belkies Jeelani, instead of Ms. Bilkees Jeelani as the first page of the service book is also enclosed as a documentary proof in her favour. Further, the objection have been duly examined with reference to the relevant records and subsequently found substantiated.

Now, THEREFORE, the final seniority list of members of the J&K Assistant Town Planners of Town Planning Organization (Gazetted) Service as it stood on 01.01.2025, forming annexure to this order, is hereby notified. The date of birth recorded in the seniority list shall be subject to further verification from the service book and matriculation certificates of the concerned officers.
