- (viii) whether the document such as M-Book / work register have been maintained.

- (ix) to fix the responsibility for delay in execution of the works (if any).
- (x) any other issue which officer may like to report upon in their findings.
- (xi) any other issue which committee may like to report upon in their findings.

The officer shall furnish the detailed report within fifteen (15) after completion of verification.
