## Government Order No. <u>99</u> HUD of 2018 Dated 11.01.2018

Sanction is hereby accorded to the release of **Rs.189.31 lacs** (**Rupees One Hundred Eighty Nine lacs & Thirty One thousand**) only as grant-in-aid of 2017-18 under Deendayal Antyodaya Yojana-National Urban Livelihood Mission (DAY-NULM) as Capital Component and its placement at the disposal of Mission Director National Urban Livelihood Mission/Vice Chairman State Urban Development Agency.

The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, NULM/VC, SUDA bearing Account No. 0110040500000075 maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar.

However, the release of funds is subject to the following conditions:-

- 1. The funds shall be utilized for the purpose these have been released;
- 2. No diversion/re-appropriation of funds so released is allowed;
- The released funds does not confer the sanction for incur the expenditure which shall be booked after observing all codal formalities;
- 4. The funds shall be utilize for implementation of scheme strictly as per originally approved components and according to Govt. of India's prescribed guidelines;
- 5. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the



current year and upto date cumulative expenditure and physical achievement.

6. The Department shall send Utilization Certificates of the funds released as early as possible and definety well before 31.3.2017 to GOI, with a copy to the Finance Department.

7. The Director Finance of the Department shall vouchsafe the utilization of funds as per codal procedure/Got. Of India's guidelines.
