- iv. The funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- v. The funds shall be utilized on the approved components of the project/ schemes only and no new work/scheme shall be taken up without the approval of the competent authority;
- vi. The implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme or any other source;
- vii. The funds so released shall not be available for any reappropriation/diversion;
- viii. The expenditure shall commensurate with the physical progress achieved;
- ix. All video graphic/photographic evidence of works both shall be maintained;

- X. The physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- xi. No expenditure shall be incurred against revised cost which has not been approved by the competent authority;
