- (iv) the funds shall not be utilized for the schemes/works which have not been approved by the Administrative Department.
- (v) the funds shall not be utilized on clearance of any past liability, repair renovation & Maintenance work
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;

- (vii) the funds so released shall not be available for any reappropriation/diversion;
- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) all video graphic/photographic evidence of works both shall be maintained.
- (x) the physical and financial progress report shall be furnished to the Administrative Department well in time;
- (xi) the implementing agency shall follow up the procedural mechanism of CAS MIS System;
- (xii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
