Ref: - Planning & Dev. Department's authorization conveyed vide Govt. Order No. 126-PD of 2015 dated 16.07.2015 & Govt. Order No. 26-PD of 2016 dated 03.02.2016.

In continuation to Govt. order No. 63- HUD of 2016 Dated 29.02.2016, sanction is hereby accorded to the release of *Rs. 18.75 Lacs ( Rupees Eighteen Lacs & Seventy Five Thousand)* only in favour of *Managing Director J&K Housing Board of Housing sector* – Capex Budget 2015-16 to be utilized for ongoing scheme *“Upg. of civic system in existing colonies”* during the current financial year 2015-16.

The Director Finance H&UDD shall draw the funds in advance through WDC bill and place the same at the disposal of Managing Director J&K Housing Board.

The release & subsequent utilization of funds is subject to the following conditions that: -

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities.
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority.
- (iii) the funds so released shall not be available for any re-appropriation/diversion.
- (iv) the funds shall not be applicable for utilization for clearance of the past liability.
- (v) the Utilization Certificate for the released amount shall be submitted to the Department.
- (vi) all the UCs/Red Accounts of previous advance drawl have been rendered to the concerned quarter.
- (vii) the Red Accounts is expedited to the audit office without any delay.
- (viii) the expenditure shall commensurate with the physical progress achieved.
- (ix) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained.
- (x) the amount shall be incurred to the benefit of the general public of the area not to the interest of any individual.
