The above amount shall be drawn in advance by Director Finance, Housing & Urban Development Department from Civil Secretariat, Treasury by debit to Major Head 2217-UD Grant-In-Aid and placed the same at the disposal of Vice Chairman, Lakes & Waterways Development Authority (LAWDA)i.e S/B Account No.022901020000004-J&K Bank, Branch Braine, Srinagar.
- 2. The concerned HOD/DDO is advised to incur the expenditure on authorized and permissible objects of expenditure only, after observing all codal formalities required under rules and no diversion of funds shall be permissible.
- The expenditure shall strictly be incurred for the purpose for which the fund under GIA has been sanctioned/ released.
- 4. Utilization Certificate and detailed object wise accounts of expenditure against the funds shall be submitted to the Administrative Department immediately.
- The DDO is advised that the expenditure shall be made as per the object wise details already submitted to Administrative Department/Finance Department under the Budget Estimates 2017-18.
