Whereas the instant case was registered on the outcome of verification conducted into the complaint regarding the allegations that dozens of male/ female persons have been appointed by officers/officials of Municipal Committee Ganderbal through backdoor entries during year 2009-10; and

Whereas is alleged that during the year 2009-10 the officers/officials of Municipal Committee Ganderbal namely Ab. Rashid Mir the then I/C Executive Officer Municipal Committee Ganderbal now retired. Mohd Khalid Bhat then Executive Officer Municipal Commitzee Ganderbal now Executive Officer Municipal Committee Khrew and Gowar Ali Tigoo the then Secretary Municipal Committee Ganderbal now In-charge Executive Officer Municipal Committee Devsar Kulgam in league with beneficiaries have by abuse of their official positions made illegal appointments di 11 accused beneficiaries namely (1). Ali Mohammad Mir S/o Ghulam Ahmad Mir, Rio Arampora Ganderbal appointed as Khilafwarzi Assistant, (2). Imtiyaz Ahmad Mir S/o Mohammad Sultan Mir R/o Srinagar appointed as Khalif Warzi Assistant (3). Miss Gowhar Jan Haroo D/o Ghulam Hassan Harm Rio Khankah-i-Mohalla appointed as Jr. Assistant (4). Abdul Wahid SP) Abdul Majid Mir R/o Syedpora Humchi appointed as Jr. Assistant (5). Ghulam Mohi-ud-din Bhat 5/0 Ghulam Qadir Bhat R/o Syedpora Humchi appointed as Khilafwarzi Assistant (6). Siraj-ud-din Mir S/o Ghulam Mohammed Mir R/o Deachigam appointed as Khilafwarzi Assistant (7). Rukhsan Rasool D/o Ghulam Rasool R/o Duderhama Ganderbal appointed as Jr. Assistant (8). Munir Ahmad Tantray S/o Abdul Rashid Tantray R/o Bemina Srinagar appointed as Cleaner (9). Ghulam Mohammad Mir S/o Ghulam Hassan Mir R/o Litter Puiwama appointed as Tax Collector (10). Andleeb D/o Gowhar Ali R/o Rainawari Srinagar appointed as Jr. Assistant (11). Mohammad Faizan Bhat S/o Mohammad Khalid R/o M. Bagh Srinagar as Jr. Assistants without any competence and in utter disregard to the standing-orders/rules governing such appointments. Verification conducted has revealed that all such appointees were lacking the eligibility criteria as laid down in recruitment rules/ orders governing these appointments. By acting in such manner, the officers/ officials of Municipal Committee

Ganderbal by abuse of their official positions conferred undue pecuniary advantage upon the aforementioned beneficiaries thereby caused corresponding loss to the state exchequer. These acts of commissions and omissions on the part of officers/officials of Municipal Committee, Ganberbal and others prima facie constitute the offences punishable under section 5(1) (d) r/w section 5(2) J&K P.C. Act Svt. 2006 and section 120-B RPC, as such the case FIR No.17/2011 P/S VOK was registered accordingly; and

- 3. Whereas during the course of investigation :he document having bearing on the case were seized and seizure memos prepared in this regard, besides, the statements of the witnesses were also recorded under section 161 Cr.P.C. The admitted signatures/handwriting of the accused persons and the questioned documents were seized during the course of investigation which were sent to FSL for examination and opinion; and
- 4. Whereas investigation has revealed that in some instances FSL Srinagar with regard to signatures of Ab. Rashid Mir then Executive Officer Municipal Committee Ganderbal on few appointment orders could not furnish its opinion however the staff posted and acquainted with the facts of the case/writings of Issuing Authority have identified the signatures of Ab. Rashid Mir then Executive Officer Municipal Committee Ganderbal; and
- Whereas the investigation conducted into the case has revealed that the Government of Jammu and Kashmir Housing and Urban Development Department has formulated J&K Urban Local Bodies Institutions (management) service Recruitment Rules 2008 under SRO No. 417 dated 18.12.2008 attested copy of which was obtained and placed on file which in brief reveals that no person shall be eligible for appointment or promotion to any post in any class, Category or Grade in the service unless he/she possesses the qualification as laid down in schedule 2nd and fulfills other requirements of recruitment as provided in the rules and orders for the time being in force. The rules further reveal that the competent Authority for making appointments to the posts under these Rules shall be the Government in case of class-I and class-II posts and respective Head of Department in other cases. As per Schedule II of these Rules for the posts of Junior Assistants/Tax Collector Minimum Qualification for direct recruitment is Graduation from any recognized University with knowledge of typewriting having not less than 35 words speed per minute and six months certificate course in computer application from a recognized institute, and for the posts of Khilaf Warzi Assistants minimum qualification for direct recruitment is two years Draftsman course from any recognized institute for the posts of cleaner/ Demolition Guard the minimum requisite qualification is Matric and maximum 10+2; and
- Whereas the investigation conducted has revealed that Shri Abdul Rashid Mir and Mohammad Khalid Bhat have remained posted as Incharge Executive Officer Municipal Committee Ganderbal w.e.f 2008 to 10/2010 and w.e.f 10/2010 to 12/2010 respectively .Shri. Gowher Ali Tigoo has remained posted as Secretary Municipal Committee Ganderbal w.e.f 2007 to 12/2010 and Shri Majaz Rasool Dar was functioning as Computer Assistant during year 2008 to 2010. Shri Ab Rashid Mir has retired on 01/12/2010 and Gowher Ali Tigoo, Mohammad Khalid Bhat, Majaz Rasool

Dar are in service. The beneficiaries are still working in Municipal Committee Ganderbal except Muneer Ahmad Tantary who is not on the pay rolls of Municipal Committee Ganderbal, While as Ali Mohammad Mir is presently posted at Municipal Committee Khanshaib Budgam; and

7. Whereas, during the course of investigation it was found that following 11 accused public servants (beneficiaries) rave been appointed illegally in Municipal Committee Ganderbal during the years 2009 and 2010.

### (1) Abdul Wahid Sio Ab Majid Mir R/o Syedpora Hamchie Ganderbal:-

The personal file of the accused beneficiary namely Abdul Wahid 'Mir S/o Ab Majid Mir R/o Syedpora Hamchie Ganderbal seized during the course of investigation reveals that the accused beneficiary has been appointed vide order No.MC/GBL/09/ 6270-31 dated 01.08.2009 issued by Executive Officer Municipal Committee, Ganderbal and he was appointed as Junior Assistant in the pay scale of Rs.3050-4910 (pre-revised). The copies of the said appointment order were forwarded to Director, Urban Local Bodies Kashmir for favour of information and confirmation, Accounts/Establishment section for information and necessary action and to accused beneficiary for compliance. The accused beneficiary Abdul Wahid Mir S/o Ab Majid Mir R/o Syedpora Hamchie Ganderbal submitted his joining report on 30.08.2009.

During the course of investigation it was found that the accused beneficiary Abdul Wahid Mir S/0 Ab. Majeed Mir R/O Syedpora Hamchie is nephew of Ab. Rashid Mir then Executive Officer Municipal Committee Ganderbal as authenticated by Executive Officer Municipal committee Ganderbal vide No.MC/GBL/2014/2361 dated 15.12.2014 and also authenticated by witnesses.

As per pay details provided by Municipal Committee Ganderbal, the accused beneficiary has drawn salary W.e.f 01/2010 to 03/2014 amounting to Rs.5,45,772/-.

# (2) Gowhera Jan Haroo D/o Gh Hassan Haroo R/o Khankahi Mohalla Srinagar.

The personal file of the accused beneficiary namely Gowhera Jan Haroo D/o Gh Hassan Haroo R/o Khankahi Mohalla Srinagar seized during the course of investigation reveals that the accused beneficiary has been appointed Vide No.MC/GBL/09/1623-25 dated 31.01.2010 by Executive Officer Municipal Committee Ganderbal and she was appointed as Junior Assistant in the pay scale of Rs.2550-3200 (pre-revised). The copies of the said appointment order were forwarded to Director Urban Local Bodies Kashmir for favour of information and confirmation, Accounts/Establishment Section for information and necessary action and to the accused beneficiary for compliance. The accused beneficiary Gowhera Jan Haroo submitted her joining report on 01.02.2010.

As per pay details provided by Municipal Committee Ganderbal the accused beneficiary has drawn salary W.e.f 01/02010 to 03/2014 amounting to Rs.4,02,770/-.

### (3). Imtiyaz Ahmad Mir S/o Mohd Sultan Mir R/o Wanihama Srinagar

The personal file of accused beneficiary namely Imtiyaz Ahmad Mir S/o Mohd Sultan Mir R/o Wani Hama Srinagar seized during the course of investigation reveals that accused beneficiary has been appointed vide order No. No.MC/GBL/09/ 814-17

dated 09.09.2009 issued by Executive Officer Municipal Committee Ganderbal and he was appointed as Khilaf-warzi Assistant in the pay scale of Rs.2550-3200 (pre-revised). The copies of the order of the said appointment were forwarded to Director Urban Local Bodies Kashmir for favour of information and confirmation, Accounts/ Establishment section for information and necessary action and to accused beneficiary for compliance. In the said appointment order residence of accused beneficiary was shown Srinagar later Corrigendum vide No.MC/GBL/227-300 dated 30.06.2010 was issued with regard to his residential address read as Wanihama instead of Srinagar. The accused beneficiary Imtiyaz Ahmad Mir submitted his joining report on 10.09.2009.

As per salary statement furnished by Executive Officer Municipal Committee Ganderbal the accused beneficiary has drawn salary W.e.f 01/2010 to 03/2014 amounting to Rs.4,24,145/-.

## 4. All Mohammad Mir S/o Gh. Ahmad Mir R/o Arampora R/o Arampora Ganderbal;

The personal file of accused beneficiary namely All Mohammad Mir 5/0 Gh Ahmad Mir R/o Arampora R/o Arampora Ganderbal seized during the course of investigation beneficiary has been accused appointed that the No.MC/GBL/09/663-66 dated 08.08.2009 by Executive Officer Municipal Committee Ganderbal and he was appointed as Khilafwarzi Assistant in the pay scale of Rs.3050-4910 (pre-revised). The copy to order of the said appointment order were forwarded Director Urban Local Bodies Kashmir for favour of information and confirmation, Accounts/Establishment Section for information and necessary action and to the accused beneficiary for compliance. The accused beneficiary All Mohammad Mir submitted his joining report on 09.08.2009. The personal file of the said accused beneficiary reveals that he has been relieved as Demolition Guard for Municipal Committee Khansahib vide order bearing No.MC/GBL/10/813-17 dated 29.11.2010 in pursuance to order No.DULB/ESTT/884 of 2010 dated 16.11.2010 issued by Director Urban Local Bodies Kashmir wherein the Executive Officer, Municipal Committee, Ganderbal has been asked to relieve him only after verifying service record of the accused beneficiary transferee.

As per salary statements the said accused beneficiary has been paid a total salary of Rs.2,27569./- till 06/2014 i.e. Rs.101032.00 from Municipal Committee, Ganderbal and Rs.126537.00 from Municipal Committee, Khansahib.

## (5). Gh. Mohammad Mir S/o Gh. Hasan Mir R/o Litter Pulwama

The personal file of accused beneficiary namely Gh. Mohammad Mir S/o GH Hasan Mir R/o Litter Pulwama seized during the course of investigation reveals that the accused beneficiary has been appointed vide order No.MC/GBL/721-24 dated 30.10.2010 issued by Executive Officer Municipal Committee Ganderbal and he was appointed as Tax Collector in the pay scale of Rs.2550-3200 (pre-revised). The copies of the said appointment order were forwarded Director Urban Local Bodies Kashmir for fayour of information, Examiner Local Fund Audit, Srinagar for information, Accounts/

As per salary statements the said accused beneficiary has received Rs.3,64,364/- as salary w.e.f. 01/2010 to 03/2014.

#### 6) Andleeb D/o Gowher Ali Tigoo Rio Rainawarie Srinagar.

The personal file of accused beneficiary namely Andleeb D/o Gowher Ali Tigoo R/o Rainawarie Srinagar seized during the course of investigation reveals that the accused beneficiary has been appointed vide order No.MC/GBL/721-24 dated 30.10.2010 issued by Executive Officer Municipal Committee Ganderbal and he was appointed as Jr. Assistant in the pay scale of Rs.2550-3200 (pre-revised). The copies of the said appointment order were forwarded to Director Urban Local Bodies Kashmir for favour of information Examiner Local Fund Audit, Srinagar for information, Accounts/Establishment Section for information and necessary action and to the accused beneficiary for compliance. The investigation has revealed that accused beneficiary is the daughter of accused Gowher Ali Tigoo the then Secretary Municipal Committee, Ganderbal.

As per salary statements the said accused beneficiary has received Rs.2,27,480/- as salary w.e.f. 10/2010 to 03/2014.

# (7). Mohd Faizan Bhat S/o Mohd Khalid Bhat R/o Main Bazar Reasie at Present Munder Baigh Srinagar.

The personal file of accused beneficiary namely Mohd Faizan Bhat S/o Mohd Khalid Bhat R/o Main Bazar Reasie at Present Munder Baigh Srinagar seized during the course of investigation reveals that the accused beneficiary has been appointed vide order No.MC/GBL/721-24 dated 30.10.2010 issued by Executive Officer Municipal Committee Ganderbal and he was appointed as Jr. Assistant in the pay scale of Rs.2550-3200 (pre-revised). The copies of the said appointment order were forwarded Director Urban Local Bodies Kashmir for favour of information and Examiner Local Fund Audit, Srinagar for information, Accounts/Establishment Section for information and necessary action and to the accused beneficiary for compliance.

The copies of the said appointment order were forwarded to Director Urban Local Bodies Kashmir for favour of information, Examiner Chief Accounts Officer, Local fund Audit Srinagar for information, Accounts/Establishment Section for information and necessary action and to the accused beneficiary for compliance.

Investigation conducted has revealed that the accused beneficiary accused is the sister of Majaz Rasool Dar S/o Gh Rasool Dar R/o Duderhama Ganderbal, who was posted as Computer Assistant in Municipal Committee Ganderbal When the appointment order of his sister was issued which proves criminal conspiracy among the accused. Earlier the accused beneficiary has been shown as consolidate worker in Municipal Committee Ganderbal.

As per salary statements the said accused beneficiary has received Rs.2,84,622/- as salary w.e.f. 01/2010 to 03/2014.

#### 10. Siraj-ud-Din S/o Ghulam Mohammad Mir R/o Deachigam Bandipora.

The personal file of accused beneficiary namely Siraj-ud-Din S/o Ghularn Mohammad Mir R/o Deachigam Bandipora seized during the course of investigation reveals that the accused beneficiary has been appointed vide order No.MC/GBL/09-619-22 dated 30.07.2009 issued by Executive Officer Municipal Committee Ganderbal and he was appointed as Khilafwarzi Assistant in the pay scale of Rs.3050-4910 (prerevised). The copies of the said appointment order were forwarded to Director Urban Local Bodies Kashmir for information and confirmation, Accounts/Establishment Section for information and necessary action and to the accused beneficiary for compliance. The accused beneficiary Siraj-ud-Din submitted his joining report on 31.07.2009.

As per salary statements the said accused beneficiary has received Rs.5,56,080/- as salary w.e.f. 09/2009 to 03/2014.

### (11) Gh. Mohi Ud Din Bhat S/o Gh Qadir Bhat R/o Syedpora Hamchie:-

The personal file of accused beneficiary namely Gh. Mohi Ud Din Bhat S/o Gh Qadir Bhat R/o Syedpora Hamchie seized during the course of investigation reveals that the accused beneficiary has been appointed vide order No.MC/GBL/09-619-22 dated 30.07.2009 issued by Executive Officer Municipal Committee Ganderbal and he was appointed as Khilafwarzi Assistant in the pay scale of Rs. 3050-4910 (pre0revised).



Whereas the investigation conducted into the case has further revealed that in SWP No. 1277/2011 filed by the accused beneficiary namely Muneer Ahmad Tantary S/o Ab Rashid Tantary R/o Abu Bakar Colony Bemina Srinagar Wherein the petitioner has sought indulgence of Hon'ble High Court of J&K at Srinagar for commanding the respondents to allow the petitioner to continue against the post of Cleaner on the basis of his appointment order and the Hon'ble Court by an order dated 10.09.2012 observed that if any recruitment is to be made for class IV posts due selection process is required to be followed and court further observed that the petitioner came to be engaged without following due procedure established under law and the order of the appointment issued by the Executive Officer on the face of it is dehors of Rules and without any competence which is back door entry and thereby dismissed the petition of petitioner, consequently the accused beneficiary filed an LPA against the Judgment dated 10.09.2012 before Hon'ble Divisional Bench High Court of J&K and the said LPA No. 196/2012, CMP No. 327/2012 vide order dated 09.04.2013 dismissed alongwith the connected CMPs, and
- 9. Whereas during the course of investigation the details of vacancy statement have been obtained from Executive Officer Municipal Committee Ganderbal vide No. MC/GBL/2014/2361 dated 15.12.2014 which have revealed as under:-

Whereas the investigation conducted has further revealed that as per the communication No.MC/GBL/2014-2361 dated 15.12.2014 of present Executive Officer Municipal Committee Ganderbal and as per statements of witnesses there is close relation between the then Executive Officer namely Ab Rashid Mir with accused beneficiary namely Abdul Wahid Mir and another accused beneficiary Ghulam Mohi-ud-Din Bhat is also close neighbor to him. The accused beneficiary Miss Andleeb is Daughter of Then Secretary Municipal Committee Ganderbal Gowher Ali Tigoo. The accused beneficiary namely Mohd Faizan Bhat is the Son of Mohd Khalid Bhat the then

- Whereas during the course of investigation the Directorate of Urban Local Bodies Kashmir vide their communication No.DULB/ESTT./3722/5188 dated 19.07.2014 in reference to letter No.SSP-VOK/14/1923 dated 14.07.2014 has communicated that Directorate has not received the copies of above mentioned appointment orders of beneficiaries; and
- Whereas investigation has revealed that as per Schedule II of recruitment Rules for the posts of Junior Assistants Minimum Qualification for direct recruitment is Graduation from any recognized University with knowledge of typewriting having not less 35 words speed per minute and six months certificate course in computer application from a recognized institute, while as the accused beneficiary has passed only 10+2 examination and was lacking eligibility criteria; and
- 13. Whereas it is also alleged that the Executive Officer is not competent for making appoint of Junior Assistant at per SRO 417 dated 18.12.2008 as the competence is lying with Head of Department for making such type of appointments; and
- Whereas it is also alleged that the appointments have been was made without making any kind of advertisement, interview/written test and the accused beneficiaries have not participated in any recruitment process as per recruitment procedures/rules, as such they have made back door entry in the Department in league with the accused public servants; and
- Whereas, the Competent Authority after considering the records and evidence collected by the investigating agency and applying its mind to the facts and circumstances of the case is satisfied that prima facie a case for commission of offences punishable under section 5(1) (d) r/w 5(2) J&K P.C. Act Svt. 2006 and section 120-B RPC is made out against the following accused persons:-
  - Abdul Rashid Mir S/o Late Abdul Gaffar Mir R/o Syed Pora Hamchie Ganderbal then Executive Officer Municipal Committee, Ganderbal (now retired).
