Accord of retrospective effect to the promotion of Mr. Rajinder Kumar Tutoo and Mr. Pushpati Nath Koul as Divisional Town Planners, Srinagar Municipal Corporation.

Whereas, Mr. Rajinder Kumar Tutoo and Mr. Pushpati Nath Koul, currently working as Divisional Town Planners, SMC (referred to herein below as the petitioners), have filed multiple number of writ petitions before the Hon'ble High Court of Jammu and Kashmir. The latest of such writ petitions, SWP No.812/2017 has been disposed of by the Hon'ble High Court vide order dated 4th May, 2017, operative portion whereof reads as under:-

"11. In view of above, the writ petition is admitted to hearing, impugned order dated 10 April, 2017, passed by the respondent No.2 is set aside and the respondent No.2 is directed to pass a reasoned order with regard to the claim of the petitioners on its own merit within a period of 3 weeks from the date of receipt of copy of this order."

Whereas, the reliefs sought by the petitioners in the writ petition SWP No.812/2017 read as under:-

- i) Issuance of writ of certiorari for quashment of government order No.108-HUD of 2017 dated 10.04.2017. and
- ii) Issuance of writ in the nature of mandamus commanding the respondents to implement the judgment of this Hon'ble Court passed in SWP No.30/2014 in its letter and spirit by performing their legal obligation and duty of fairness by terminating discrimination and denial of accord of earned service promotions vis-à-vis their counterparts belonging to the same service, category, class, grade and category in its initial appointment till earning of promotion both by petitioners as Divisional Town Planners as well as their

- counterpart as Divisional Town Planner with retrospective effect. And
- iii) Issuance of any other writ, order or direction which this Hon'ble Court deems fit and proper in the attending circumstances of the case.

Whereas, before according consideration to the claim of the petitioners on merits, it is imperative to summarize the claim of the petitioners in the matter on hand; and

Whereas, the petitioners seek parity with respect to their service benefits on retrospective basis, with one Mr. Mehraj-ud-Din Bhat, Divisional Town Planner, since retired; and

Whereas, it is imperative to tabulate the comparative service of the petitioners and the said Mr. Mehraj-ud-Din Bhat in order to ascertain whether any disparity or otherwise exists. The comparative table of the petitioners and the aforesaid Mr. Mehraj-ud-Din Bhat is as under:-

Whereas, it is abundantly clear that even though the petitioners and the said Mr. Mehraj-ud-Din Bhat initially have been appointed as Draftsman, the similarity in their service careers diverges immediately thereafter, for, whereas the aforesaid Mr. Mehraj-ud-Din Bhat has been promoted from the post of draftsman to the post of Head Draftsman, vide order No.1526 of 1995 dated 15.03.1995, retrospective effect w.e.f 25.02.1981 vide No.2169 of 1986 dated 04.03.1986 then to the post of Assistant Town Planner vide order No.18 of 1986 dated 05.04.1986 and then to the post of Divisional Town Planner (vide government order No.222 of 2004 dated 09.08.2004) all promotions in the Planning Wing of the Corporation), the petitioners have been granted promotions

Whereas, the claim of the petitioners has been again considered after going through the entire record and the matter has been considered in its entire conspectus; and

Whereas, it is seen that the petitioners have reaped the fruits of promotion, in the Engineering Wing, on which side they rose to the level of Assistant Executive Engineers and have not resented to such promotions at the relevant point of time and accepted the said promotions without reserving their rights to get promotion on the Planning Side of the Corporation, along-with all service benefits accruing there from; and

Whereas, the case of the petitioners that they form one class with the aforesaid Mr. Mehraj-ud-Din Bhat is not manifest from the record, inasmuch as the petitioners and the said Mr. Mehraj-ud-Din Bhat have risen to the post of Divisional Town Planner through different channels viz: Engineer and Planning Wing; and

Whereas, the petitioners cannot on the one hand reap the benefits of their promotions on the Engineering Side and on the other hand claim retrospective promotions to the post of Assistant Town Planner and Divisional Town Planner on par with the said Mr. Mehraj-ud-Din Bhat. The petitioners cannot breath hot and cold in the same breath; and

Whereas, the petitioners have conveniently omitted and maintained a conspicuous silence in their writ petitions, as to how they have been promoted to the post of Assistant Engineer, Assistant Executive Engineer and Divisional Town Planner.

Now therefore, the claim of the petitioners in its entirety, and particularly in light of the findings and reasons recorded hereinabove, is found devoid of merit and is accordingly rejected. However, the case of the petitioner shall also be placed before the Departmental Promotion Committee(DPC) of the Srinagar Municipal Corporation and if the DPC finds any merit in the promotion given to the petitioners from time to time and the benefits which they claim in the instant petition, accordingly the matter can be reopened and decided. The Department needs two months time for the same.
