- (ix) all video graphic/photographic evidence of works both shall be maintained.
- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
- (xi) the implementing agency shall ensure the submission of physical and financial progress report to the Admn. Deptt. well in time;
- (xii) the physical verification of the works be conducted by the Sr. officers hierarchy to ascertain ground existence, quality parameters and execution as per approved DPR/detailed estimates as well as benefit to the public.
