The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Commissioner, SMC and Commissioner, JMC.

The release & subsequent utilization of funds is subject to the following conditions that: -

the funds shall be placed at the disposal of subordinate executive agencies within seven days from the issuance of the order and copy endorsed to the Administrative Department;

the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;

the execution of the works be taken up after seeking formal approval of iii. the works so identified/prioritized from the Administrative Department;

the funds shall be utilized on those components of the schemes only İ٧. which have been technically sanctioned and administratively approved by the Competent Authority;

the implementing agency shall ensure that there is no overlapping of ٧. funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;

- the funds so released shall not be available for any reνi. appropriation/diversion;
- the expenditure shall commensurate with the physical progress VII. achieved.
- the UCs for the released amount shall be submitted to the department viii. for release of further funds;
- the implementing agency shall vouchsafe the utilization of funds as per ix. codal procedure/guidelines;
- all the UCs/Red accounts of advance drawls shall be rendered to the X. concerned quarters;
- the physical and financial progress report shall be furnished to the Χİ. Admin. Deptt. well in time;
- that all video graphic/photographic evidence of works both prexii. execution and post execution shall be maintained;
