The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and credit the same in the Official Bank Account of Mission Director, AMRUT and SBM as per the Account No. referred above for further release to the implementing agency/s.

The release & subsequent utilization of funds is subject to the following conditions that: -



the agency shall transfer the funds to the implementing agency (s) as per the financial pattern in the guidelines of GoI for the programme under AMRUT/SBM and for the specific purpose for which it has been released;

- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority and as per the guidelines of AMRUT/SBM scheme;

- the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- v. the funds so released shall not be available for any reappropriation/diversion;
- vi. the Director Finance of the Department shall vouchsafe the utilization of funds as per the codal procedure/guidelines of the schemes;
- the Mission Director, AMRUT/SBM shall ensure that the released State Share be restricted to the sanctioned/committed State Share against each project of the scheme;
- viii. the expenditure shall commensurate with the physical progress achieved.
- ix. the UCs for the released amount shall be submitted to the department for release of further funds;
- all the UCs/Red accounts of advance drawls shall be rendered to the concerned quarters;
- xi. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
