Subject:- Release of funds for the financial year 2017-18.

In pursuance of Finance Department's authorization. No. FD-VII-Bgt. (19) 2017-18 dated.17.08.2017, sanction is hereby accorded to the release of funds amounting to **Rs.4.80 lakhs** (Rupees Four Lakhs and Eighty Thousand only) raising the total upto date allocation to the extent of **Rs.13.30Lakhs** (Rupees Thirteen Lakhs and thirty thousand) only under Grant-In-Aid in favour of the Chief Executive Officer, Katra Development Authority for meeting the expenses under revenue account.

The expenditure on this account shall be debited as per classification given below:-

The Director Finance Housing & Urban Development Department shall draw the amount in advance from the concerned treasury through WDC bill and same shall be transferred to the official account of the CEO, KDA.

The drawing & Disbursing Officer is required to observe the following instructions strictly;

- The expenditure shall be made strictly in accordance to the classification under which funds have been authorized. No omissions/Commissions or diversion shall be made under any pretext unless specifically and separately authorized.
- There should be uniform expenditure under each object head to avoid rush of expenditure during the last quarter of the financial year.
- 3. The controlling officers shall be duty bound to ensure submission of revenue and expenditure statements to this Department on monthly basis.
- 4. The controlling Officers/DDOs shall conduct periodic reconciliation of remittances and drawls with the Treasury and the office of the Accountant General (A&E) J&K to ensure correct reflection of income and expenditure in the Finance and other Accounts.
- The Utilization certificate//Red Accounts of previous drawls have been rendered to the concerned quarter without any delay.
- The controlling Officers shall strictly inspect and supervise the public receipts and expenditure with reference to the Appropriation Act 2017 and all the standing rules and regulations.
