Sanction is accorded to the release of **Rs. 750.00 lacs (Rupees Seven Crore & Fifty lacs)** only in favour of Chief Executive Officer, J&K SUIDA as an additional funds for laying of sewer lines and shifting of utilities of "**Greater Jammu Sewerage Project**" under execution under erstwhile flagship programme of JnNURM for its utilization during the current financial year 2017-18 as per the break-up given hereunder:-

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Chief Executive Officer J&K SUIDA.

The release & subsequent utilization of funds is subject to the following conditions that:-

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority and as per the guidelines of the Scheme.
- (iii) the vetted cost of each component/activity shall not exceed in any case and all the necessary clearances/approvals shall be sought from the Competent/Regulatory Authority before implementation of the scheme.



- (iv) the implementing agency shall ensure that the reasonability of rates and complete the project within the approved cost only and there shall be no cost/time over run.
- (v) the funds so released shall not be available for any reappropriation/diversion.
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vii) the Director Finance of the Deptt. shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- (viii) the funds shall not be utilized on Revenue or Revenue like items.
- the Utilization Certificate of the amount is rendered to the concerned quarters within the stipulated time;
- (x) the expenditure shall commensurate with the physical progress achieved;
- (xi) that all video graphic/photographic evidence of works both preexecution & post execution shall be maintained;
- (xii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xiii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority
