Subject: - Implementation of Energy Efficient LED Street Light Project in Srinagar Municipal Corporation and Jammu Municipal Corporation through M/s Energy Efficiency Services Ltd.(EESL).

Sanction is hereby accorded to the: -

- (i) implementation of Energy Efficient LED Street Lights project in Srinagar Municipal Corporation and Jammu Municipal Corporation through M/s Energy Efficiency Services Limited (EESL), a Joint Venture Company setup by the Ministry of Power, Government of India subject to obtaining all necessary clearance and approval from Competent Authority;
- (ii) signing of tripartite Memorandum of Understanding (MoU) between Housing & Urban Development Department (H&UDD), Power Development Department (PDD) and M/s Energy Efficiency Services Limited (EESL) for implementation of LED Street Light project in Srinagar Municipal Corporation and Jammu Municipal Corporation subject to the following conditions that:
 - a) the actual number of Street Lights to be replaced shall be worked out after undertaking joint survey by the concerned Officers of PDD, JMC, SMC and EESL.
 - b) the existing LED Lights shall not be replaced and shall be accounted while working out the actual requirement of LED lights.

the MoU shall be singed after satisfying the financial viability, ensuring the reasonability of rates and fulfilment of all codal formalities.

energy savings shall be reported by the PDD on monthly basis after the replacement of Street Lights by the EESL in both Municipal Corporations for taking further action as per agreement.

- (iii) incurring the cost of replacement of front infrastructure viz; Pole cabling, Phase wire work, fuse box, surge protector earthling arrangement, clamps, nuts bolts, brackets etc. by Power Development Department and metering of Street Lights in both the Municipal Corporations Jammu and Srinagar.
- (iv) annual repayment of M/s EESL by Planning Development and Monitoring Department/Finance Department through Capex Budget to be finalized at RE (2017-18) stage/Be (2018-19) by suitable bifurcation between allocation in the relevant LED scheme of PDD and Housing & Urban Development Department after satisfactory execution and operation maintenance of project for seven (07) years after reviewing the progress achieved.
