In continuation to Govt. Order No. 220-HUD of 2016 Dated 08.11.2016, sanction is here by accorded to the release of Rs. 25.00 Lacs (Twenty Five Lacs only) (i.e. Rs. 12.50 Lacs each) in favour of Director, Building Centre Jammu/Srinagar of Capex Budget 2016-17 under the scheme "Building Centre" of Housing Sector to be utilized for implementation of approved Action Plan/Works Programme for the current financial year 2016-17.

The Director, Finance, H&UDD shall draw the funds in advance from treasury through WDC Bills and place the same at the disposal of concerned agencies immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- ii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- iii. the funds shall not be utilized on clearance of any past liability, repair and maintenance work;
- the funds shall be utilized on the ongoing schemes/works only iv. and no new scheme shall be taken up without the approval of the competent authority;
- the implementing agency shall ensure that there is no overlapping v. of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- the funds so released shall not be available for any revi. appropriation/diversion;
- the expenditure shall commensurate with the physical progress achieved.
- the UCs for the released amount shall be submitted to the viii. department for release of further funds;

- ix. the implementing agency shall vouchsafe the utilization of funds as per codal procedure as per guidelines;
- all the UCs/Red accounts of advance drawls shall be rendered to the concerned quarters;
- xi. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
