Subject: - Release of funds of Capex Budget 2017-18 under Urban Development Sector.

Ref: - I. Planning Dev. & Monitoring Deptt's. Govt. Order No. 336-PD of 2017-dated 25.10.2017.

Govt. Order No. 237-HUD of 2017 Dated: (6 -11-2017

Sanction is hereby accorded to the release of funds to the tune of Rs. 435.00 Lacs (Rupees Four Hundred & Thirty Five Lakh) only in favour of Director, Urban Local Bodies Kashmir under State Capex Budget 2017-18 of Urban Development Sector to be utilized on the works/schemes as per the details given in Annexure "B" to this Govt. Order.

The release & subsequent utilization of funds is subject to the following conditions that;

- (i) The works against the amount so released in respect of towns, shall be got prioritized by DULBK from respective pubic representatives and the funds be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance if the Govt. order and copy endorsed to the Administrative Department
- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- the funds shall be utilized only after works identified the/prioritized by the public representative;
- (iv) the funds shall not be utilized on clearance of any past liability, repair, renovation and maintenance work and there shall be no expenditure on Revenue or Revenue like items;
- (v) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
 - (vi) the funds shall be utilized on identified schemes/works only and no other scheme shall be taken up without the approval of the competent authority;
 - (vii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
 - (viii) the funds so released shall not be available for any reappropriation/diversion;
 - (ix) the expenditure shall commensurate with the physical progress achieved;
 - (x) all video graphic/photographic evidence of works both shall be maintained;

- (xi) the physical and financial progress report shall be furnished to the Admn.
 Deptt. well in time;
- (xii) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
