- (vi) the funds so released shall not be available for any reappropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) all video graphic/photographic evidence of works both shall be maintained.
- (ix) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.

(x) the implementing agency shall ensure the submission of physical and financial progress report to the Admn. Deptt. well in time;
