- (i) the funds shall be utilized for installation of street lights in uncovered areas and restoration of already installed lights who have become defunct;
- (ii) the funds shall be utilized for the purchase of LED lights from Original Equipment Manufacturer (OEM) on competitive rates and outsource the restoration job on competitive bidding after clearly marking the defunct lights;
- (iii) the warranty clause of 24 months from, the date of installation shall be incorporated in the allotment of the contract.
- (iv) all codal formalities are strictly adhered to while booking the expenditure;
- (v) the funds so released shall not be available for any reappropriation/diversion.

- the release of funds does not confer the sanction to incur (vi) the expenditure which should be booked only after observing all codal formalities;
- the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (viii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- the expenditure shall commensurate with the physical (ix)progress achieved;
