- the implementing agency/s shall ensure that the work/s should be executed on e-tendering mode;
- (iv) the funds shall not be applicable for utilization for clearance of the past liability;
- the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (vi) the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (vii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;
- (viii) the funds so released shall not be available for any reappropriation/diversion;
- (ix) the expenditure shall commensurate with the physical progress achieved;
- (x) all video graphic/photographic evidence of works both shall be maintained;

- the physical and financial progress report shall be furnished to the Admn. (xi)Deptt. well in time;
- no expenditure shall be incurred against Revised Cost which has not been (XII) approved by the Competent Authority;
