## Government Order No: - 25 -HUD of 2016 Dated 28-01-2016

Post –facto sanction is hereby accorded to the Construction of a Community Type Latrine (5 WC with bath, Urinals and Caretaker Room) near Nag Dandhi Ashram in Achabal Town through a Non –Governmental Organization (NGO) namely "YUGANTER".

Sanction is also accorded to the release of Rs. 15.78 lacs (Rupees Fifteen lacs & Seventy Eight thousand only), in favour of Director Urban Local Bodies Kashmir under the scheme "Addl. State contribution for Individual HHL/Community Toilet - Swachh Bharat Mission" of Urban Development Sector under Capex Budget 2015-16, to be utilized on Construction of a Community Type Latrine near Nag Dandhi Ashram in Achabal Town during year 2015-16.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall not be utilized for the schemes/works which have not been approved by the Administrative Department.
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any reappropriation/diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved;

- (vii) the work be got executed under the close supervision of your technical staff and before drawing an agreement the cost estimates shall be got verified by the technical wing of the Directorate as per the SOR-2012 to confirm the reasonability of rates.
- (viii) the necessary agreement shall be drawn by the implementing agency with the concerned NGO as per standard terms & reference with the objective of utilizing the public money optimally and judiciously.
- (ix) all video graphic/photographic evidence of works both shall be maintained.
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
