The Director Finance H&UDD shall draw the funds in advance from treasury through WDC Bill and credit the same in the official Bank Account of Mission Director, NULM/VC, SUDA bearing Account No. 0110040500000075 maintained at J&K Bank Moving Branch Civil Secretariat, Jammu/Srinagar.

However, the release of funds is subject to the following conditions:-

- The funds shall be utilized for the purpose these have been released;
- 2. No diversion/re-appropriation of funds so released is allowed;
- The released funds does not confer the sanction for incur the expenditure which shall be booked after observing all codal formalities;
- The funds shall be utilize for implementation of scheme strictly as per originally approved components and according to Govt. of India's prescribed guidelines;



- 5. The Department shall send a status report about the scheme, in terms of physical and financial progress made during the current year and upto date cumulative expenditure and physical achievement.
- 6. The Department shall send Utilization Certificates of the funds released as early as possible and positively well before 31.3.2018 to GOI, with a copy to the Finance Department.
- 7. The Director Finance of the Department shall vouchsafe the utilization of funds as per codal procedure/Got. Of India's guidelines.
