Sanction is here by accorded to the release of funds of Rs. 17.50 Crore (Seventeen Crore and Fifty Lacs) only in favour of Mission Director, SBM(U) representing 50% of Matching State Share of SBM(U) amounting to Rs. 10.00 Crore and Rs. 7.50 Crore as Additional contribution of State for construction of IHHT and CT/PT in terms of Govt. Order No: 121-HUD of 2017, dated: 12.05.2017, for its utilization during current financial year (2017-18) under Swachh Bharat Mission out of State Capex Budget 2017-18 approved for the purpose in "Urban Development Sector".

The Director, Finance H&UDD shall draw the funds in advance from treasury and credit into the official bank Account of Mission Director, Swachh Bharat Mission (U), maintained in the J&K Bank Moving Sectt. Branch bearing CD Account No: **0110040500000063** immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines.
- (iii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (iv) the funds so released shall not be available for any re-appropriation/diversion;
- (v) the expenditure shall commensurate with the physical progress achieved;
- (vi) the implementing agencies shall vouchsafe the utilization of funds as per codal procedure/GOIs guidelines;
- (vii) all video graphic/photographic evidence of works both shall be maintained.
- (viii) the physical and financial progress report alongwith Utilization Certificate of the funds released shall be furnished as early as possible and definitely well before 31.3.2017 to GOI, with a copy to Finance Department.
