In continuation to Govt. Order No. 184-HUD of 2016 dated 06.09.2016, sanction is hereby accorded to the release of funds to the tune of Rs. 50.00 Lacs (Rupees Fifty Lacs) only in favour of Project officer, Charar-i-Sharief Development Project constituting 100% of the current year's approved allocation under the Scheme "Charar-i-Sharief Development Project" of Urban Development Sector thereby aggregating total releases to the extent of Rs.100.00 Lacs during the C.F.Y, to be utilized on approved works programme/Action Plan for the year 2016-17.

The release & subsequent utilization of funds is subject to the following conditions that:-

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funs shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the funds so released shall not be available for any reappropriation/diversion;
- (vi) the expenditure shall commensurate with the physical progress achieved;
- (vii) all video graphic/photographic evidence of works both shall be maintained.
- (viii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
