Whereas, in pursuance to Hon'ble Court order dated 11.09.2017 passed in WPPIL No. 09/2012 titled Shiekh Mohd. Shafi V/s Union of India and others, Mr. Aftab Rashid Pandit, then DGM J&K Housing Board Unit –II was transferred and posted as Technical Officer with Commissioner/Secretary to Govt., Housing and Urban Development Department vide Govt. Order No. 203-HUD of 2017 dated 26.09.2017.

Whereas, in pursuance to above said Govt. Order, Mr. Aftab Rashid Pandit joined as Technical Officer to Commissioner/Secretary to Govt. H& UDD on 03.11.2017 and is continuing as such till date.

Whereas, Mr. Aftab Rashid Pandit Technical officer to Commissioner/Secretary to Govt. H& UDD approached the Hon'ble High Court vide MP No. 01/2017 in WPPIL No. 09/2012 titled Shiekh Mohd. Shafi V/s Union of India and others wherein he has prayed before the Hon'ble Court to reconsider the part of order dated 11.09.2017 to the extent it concerns to the applicant therein, passed by this Hon'ble Court in the above titled Public Interest Litigation and on such reconsideration may be pleased to re-visit and recall the aforementioned part of the order dated 11.09.2017.

Whereas, the Hon'ble Court vide order dated 21.11.2017 disposed of the MP No. 01/2017, WPPIL No. 09/2012 and passed the following directions:-

"We have heard Mr. R.A. Jan, learned senior Counsel as well as the other counsel in the matter. After hearing the submission, we feel that the appropriate direction would be to require the competent authority to post Mr. Aftab Rashid Pandit to any other equivalent post as per the exigencies without being influenced by the observations made in the order dated 11.09.2017. The observations in the order dated 11.09.2017 in respect of Mr. Aftab Rashid Pandit shall also not be to his prejudice in any proceedings.

Whereas, after receipt of above said Hon'ble Court order dated 21.11.2017, the case of the petitioner (Mr. Aftab Rashid Pandit) was examined in the department.

Now, therefore in compliance to Hon'ble Court order dated 21.11.2017 passed in MP NO. 01/2017, WPPIL No. 09/2012, it is ordered that the services of Mr. Aftab Rashid Pandit presently posted as Technical officer to Commissioner/Secretary to Govt. H& UDD is placed at the disposal of MD J&K Housing Board, who shall utilize his services in the J&K Housing Board against available/vacant post.
