The release & subsequent utilization of funds is subject to the following conditions that: -

- the release of funds does not confer the sanction to incur the expenditure which (i) should be booked only after observing all codal formalities;
- the Commissioner, Srinagar Municipal Corporation shall ensure that the (ii) disbursement of the payment is made through e-transfer to Chief Engineer (CD), M/s WAPCOS Ltd. for preparation of DPRs strictly as per the Terms of Reference (TOR) of agreement and after ensuring that the DPR have been received by SMC appraised and approved by the World Bank;
- the funds so released shall not be available for any re-appropriation/diversion; (iii)
- the implementing agency shall vouchsafe the utilization of funds as per codal (iv) procedure/guidelines;
- the Utilization Certificate against the released amount be submitted to the (V) Admin. Deptt. for securing accounts;
- the expenditure shall commensurate with the physical progress achieved; (vi)
