The release & subsequent utilization of funds is subject to the following conditions that:-

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- the funds shall be utilized for execution of the scheme strictly as per originally approved components and according to GOI's prescribed guidelines which have been technically sanctioned and administratively approved by the Competent Authority;
- iii) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- iv) the funds so released shall not be available for any reappropriation/diversion;
- v) the implementing agency shall transfer the funds as per the financial pattern in the guidelines of GoI for the programme
