Sanction is hereby accorded to the release of funds to the tune of Rs. 381.40 Lacs (Rupees Three Crore Eighty One Lacs & Forty Thousand) only in favour of Director, Urban Local Bodies Jammu/Kashmir with the breakup of Rs. 215.00 Lacs to DULBK and Rs. 166.40 Lacs to DULBJ out of State Capex Budget 2016-17 under Drainage Sector for its further placement at the disposal of concerned Executive Engineers of respective Town Drainage Divisions to be utilized on the works/schemes as per the details given in Annexure "A &B" to this Govt. Order.

The release & subsequent utilization of funds is subject to the following conditions that;

(i) the funds shall be placed at the disposal of Subordinate Executing Agencies within seven days from the issuance if the Govt. order and copy endorsed to the Administrative Department;

(ii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;

(iii) the funds shall not be applicable for utilization for clearance of the past liability;

(iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;

 the funds shall be utilized on the ongoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;

(vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed from any other source viz SDRF/ District Plan/ CSS/ Flagship Programme or any other source;

(vii) the funds so released shall not be available for any reappropriation/diversion;

(viii) the expenditure shall commensurate with the physical progress achieved;

- (ix) all video graphic/photographic evidence of works both shall be maintained;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
