Sanction is hereby accorded to the temporary appointment of Smt. Mehmooda Bano W/o Late Bashir Ahmad Baba Zargar (Ex-Helper) R/o Arigam, Distt. Budgam, as Orderly, in the pay level Sl 1 (14800-47100) in J&K Urban Environment Engineering Department (UEED) in relaxation of the prescribed qualification in terms of Rule – 7 of SRO-43 of 1994.

The post of Helper held by the deceased shall be abolished by the Housing and Urban Development Department in terms of standing orders, issued by the Government in this behalf.

The appointee shall report to the Chief Engineer, J&K UEED within a period of 21 days from the date of issuance of this order and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

- a. Academic Qualification Certificates.
- b. Age and Health Certificate.
- c. Permanent Resident Certificate.
- d. Dependent Certificate.
- e. All other relevant documents required under SRO-43 of 1994.
- No loan certificate under Self Employment Scheme from, DIC concerned and Employment Department.

The appointee shall be initially on probation for a period of two years, if on verification, the certificates produced by the appointee prove to be fake or forged, the appointment shall stand cancelled ab-initio.

The salary of the appointee shall not be drawn and disbursed unless a satisfactory report about the verification of her character and antecedents are received from the Inspector General of Police, CID to whom a reference shall be made by the Chief Engineer, J&K UEED.
