

Subject: - Approval of Annual Action Plan of 2017-18 under BADP- Release of funds thereof. Ref I. Planning Dev. & Monitoring Deptt's. authorization No. PD/CSS/BADP/AAP/ 2017-18/12 Dated 29.12.2017.

Sanction is here by accorded to the release of funds amounting to Rs. 414.15 Lacs (Rupees Four Hundred Fourteen Lakh & Fifteen Thousands) only under Border Area Development Programme (BADP) comprises Rs. 372.73 Centre Share and Rs. 41.42 Lacs as State Share in favour of Director Urban Local Bodies Jammu/Kashmir (Rs. 207.06 Lakh to DULBJ and Rs. 207.09 Lakh to DULBK) for its further placement at the disposal of Executive Engineer of Town Drainage Jammu /Kashmir under Drainage Sector, for implementation of the Current Year's Annual Action Plan of ongoing/new Town Drainage schemes as per schematic details given in Annexure "A" to this Govt. Order.

The release & subsequent utilization of funds is subject to the following conditions that:-

- the execution/implementation of works/schemes be carried out after observing all the codal formalities and as per the guidelines on BADP issued by MHA, Gol and the instructions issued by the PD&MD from time to time.
- ii. the funds released shall be strictly utilized for approved Action Plan conveyed by the department under BADP;
- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- iv. the funds shall be utilized only the schemes/works and components as per DPR approved by the GoI;
- v. the UCs of the funds released shall be furnished to the department expeditiously for availing the 2nd instalment as per the format devised by GoI under BADP;
- vi. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- vii. the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Capex Budget/District Capex Budget/CSS/Flagship programme or any other source;
 - viii. the funds so released shall not be available for any re-appropriation/diversion;
 - ix. the expenditure shall commensurate with the physical progress achieved;

- that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
- xi. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time;
- xii. no expenditure shall be incurred against revised cost which has not been approved by the competent authority;
- xiii. the physical verification of the works be conducted by the Senior Officers hierarchy to ascertain ground existence, quality parameters and execution as per detailed estimates as well as benefit to the public;
