

Government Order No: 43 - HUD of 2016 Dated 18 -02-2016

In continuation to Govt. Order No. 45-HUD of 2015 dated 18.02.2015, sanction is hereby accorded to the release of Rs. 24.76 lacs (Rupees Twenty Four lacs & Seventy Six thousand) only in favour of Director Urban Local Bodies, Jammu under Emergent Public Demands of Urban Development Sector Capex Budget 2015-16 for its utilization on account of Construction of Nallah Walling & allied works and links from H/o. S. K.D.Maini to Police Station Poonch Town, thereby aggregating total releases to the extent of Rs. 49.76 lacs under the scheme.

The release & subsequent utilization of funds is subject to the following conditions that

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;

- (vi) the expenditure shall commensurate with the physical progress achieved;
- (vii) all video graphic/photographic evidence of works both shall be maintained;
- (viii) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
