In continuation to Govt. Order No. 199-HUD of 2017 dated 15.09.2017, sanction is hereby accorded to the release of funds amounting to **Rs. 30.00 Lacs (Rupees thirty Lakh)** only Rs. 15.00 Lacs each in favour of **Director Building Centre Jammu/Srinagar** representing balance 50% of approved allocation under the scheme "Building Centre" of State Capex Budget 2017-18 under Housing Sector to be utilized for implementation of approved Action Plan /Works Programme during current financial year 2017-18.

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds so released shall not be available for any re-appropriation/diversion;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the Director Finance/Joint Director (P&S) of the Deptt. Shall vouchsafe the utilization of funds as per codal procedure/guidelines;

The implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;

the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;

(viii) the expenditure shall commensurate with the physical progress achieved;

- the physical and financial progress report shall be furnished to the Admn. Deptt. Well in time, i.e. 5th of succeeding month;
- no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
