- iii. the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- the lunds shall not be utilized on clearance of any past liability, repair and maintenance work;
- the funds shall be utilized on the engoing schemes/works only and no new scheme shall be taken up without the approval of the competent authority;
- the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- vii. the funds so released shall not be available for any re-appropriation/diversion;

- viii. the expenditure shall commensurate with the physical progress achieved;
- ix. the UCs for the released amount shall be submitted to the department for release further funds;
- ine implementing agency shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- xi. all the UCs/Red accounts of advance drawls shall be rendered to the concerned quarters;
- xii. the physical and financial progress report shall be furnished to the Admin. Deptt. well in time, i.e. 5th of succeeding months;
- xiii. that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained
