Rs. 17.97278 lacs (Rupees Seventeen lacs Ninety Seven thousand two Hundred Seventy Eight) only in favour of Deputy Commissioner/ CEO, LAHDC Leh as ACA (2nd installment) for Capital Creation under RAY Projects subsumed in PMAY (Urban) for the year 2017-18 to be utilized for Pilot Projects for in-situ upgradation of 5 slums in Leh Old Town.

However, further release of funds shall be subject to fulfilment of the following conditions:-

- 1. The funds shall be utilized for the purpose these have been released;
- 2. No diversion/re-appropriation of funds so released is allowed;
- 3. The released funds does not confer the sanction to incur the expenditure which shall be booked after observing all codal formalities;
- 4. The funds shall be utilized for implementation of scheme strictly as per originally approved components and according to Govt. of India's prescribed guidelines;
- 5. The Progress report about the scheme, in terms of physical and financial progress achieved during the current year and upto date cumulative expenditure and physical achievement be sent to this Department regularly;
- 6. The implementing Agency shall send Utilization Certificates of the funds released as early as possible and definitely well before 31.3.2018 to GOI, with a copy to the Finance Department.
- 7. The Agency shall vouchsafe the utilization of funds as per codal procedure/Govt. of India's guidelines.
