

Sanction is hereby accorded to the release of funds to the tune of Rs. 200.00 Lacs (Rupees Two Hundred Lacs only) along with its advance drawal in favour of Managing Director, J&K Housing Board, as additionality under the scheme "Construction of Community Halls in Cities/Towns" of Housing Sector under Capex Budget 2015-16 to be utilized for Construction of Syed Janbaz Wali Memorial Community Centre at Baramulla.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of MD, J&K Housing Board, Jammu.

The release & subsequent utilization of funds is subject to the following conditions that:-

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds so released shall not be available for any reappropriation/diversion;



- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the Director Finance/Joint Director (P&S) of the Deptt. Shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- (vi) the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;
- (vii) the expenditure shall commensurate with the physical progress achieved;
- (viii) that all video graphic/photographic evidence of works both preexecution and post execution shall be maintained;
- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. Well in time;
- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.

This issues with the concurrence to the advance drawal of funds conveyed by Finance Department as referred to above.
