- (ix) that all video graphic/photographic evidence of works both pre-execution and post execution shall be maintained;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. Well in time, i.e. 5th of succeeding month;
- no expenditure shall be incurred against Revised Cost which has not been approved (xi) by the Competent Authority;
