In continuation to Govt. Order No. 210-HUD of 2016 Dated 21.10.2016, sanction is here by accorded to the release of funds to the tune of Rs. 89.31 Lac (Rupees Eighty Nine Lacs & Thirty One Thousand) only under Border Area Development Programme (BADP) with the breakup of Rs. 74.11 Lacs in favour of Director Urban Local Bodies Jammu and Rs. 15.20 Lacs in favour of Director Urban Local Bodies Kashmir for its further placement at the disposal of Executive Engineer's of Town Drainage Division Kashmir/Jammu, for implementation of the current year's action plan of ongoing Border Town Drainage Schemes of both the provinces to the extent as per details given in Annexure "A".

The release & subsequent utilization of funds is subject to the following conditions that:-

- The funds released shall be strictly utilized for approved Action Plan conveyed by the department under BADP and shall be further released to the implementing agencies within a week's time from the issuance of this order;
- ii. the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities, expenditure be restricted only within approved allocation and no liability be created on this account;
- iii. the funds shall be utilized only the schemes/works and components as per DPR approved by the GoI;
- the UCs of the funds released shall be furnished to the department expeditiously iv. for availing the 2nd installment as per the format devised by GoI under BADP;
 - the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- the funds shall not be utilized on clearance of any past liability, repair and maintenance work;
- The implementing agency shall ensure that there is no overlapping of funds for the vii. works being executed form any other source such as SDRF/State Plan/District Plan/CSS/Flagship programme or any other source;
- viii. The funds so released shall not be available for any re-appropriation/diversion;
- the expenditure shall commensurate with the physical progress achieved; ix.
- all video graphic/photographic evidence of works both shall be maintained; X.
- the physical and financial progress report shall be furnished to the Admin. Deptt. xi. well in time;

xii. no expenditure shall be incurred against revised cost which has not been approved by the competent authority;
