# Government Order No: - 65 HUD of 2016 Dated 03-03-2016

Sanction is hereby accorded to the release of funds amounting to Rs. 605157 (Rupee Six Lacs Five Thousand One Hundred Fifty Seven) only in favour of "Director Urban Local Bodies, Kashmir" for its further placement at the disposal of Executive Engineer Local Bodies Kashmir under the object head "Clearance of work done liabilities" of Urban Development Sector of Capex Budget 2015-16 for its utilization of "Construction of path from H/o Gh. The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the funds shall be placed at the disposal of subordinate executing agencies within 7 days from the issuance of the order and copy endorsed to the Administrative Department;
- (ii) the implementing agency shall ensure that there is no overlapping of funds, for the works being executed from any other source such as, SDRF, District Plan, CSS, BADP, CDF, MPLADs etc.;
- (iii) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (iv) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the funds so released shall not be available for any reappropriation/diversion;
- (vii) the expenditure shall commensurate with the physical progress achieved:
- (viii) all video graphic/photographic evidence of works both shall be maintained.



- (ix) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (x) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority.
