## Govt. Order No. 7 | -HUD of 2016 Dated: 04 -03-2016

In continuation to Govt. Order No. 02-HUD of 2016 dated 06.01.2016, sanction is accorded to the release of Rs. 25.00 lacs (Rupees Twenty Five lacs) only, in favour of Commissioner Municipal Corporation, Jammu under the Scheme "Capital City Dev. Programme" of Urban Development Sector - Capex Budget 2015-16 to be utilized on approved Action Plan/Works Programme during the year 2015-16, thereby aggregating the total releases to the extent of Rs. 100.00 lacs made so far under the scheme in favour of Commissioner Municipal Corporation Jammu.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of SMC in the shape of Hundi.

The release & subsequent utilization of funds is subject to the following conditions that:-

- the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds shall be utilized on the ongoing schemes/works only.
- (iv) the funds so released shall not be available for any reappropriation/diversion.
- (v) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (vi) the Director Finance of the Deptt. shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- (vii) the Utilization Certificate of the amount is rendered to the concerned quarters within the stipulated time;



- (viii) the expenditure shall commensurate with the physical progress achieved;
- (ix) that all video graphic/photographic evidence of works both preexecution & post execution shall be maintained;
- (x) the physical and financial progress report shall be furnished to the Admn. Deptt. well in time;
- (xi) no expenditure shall be incurred against Revised Cost which has not been approved by the Competent Authority
