- the implementing agency shall ensure that there is no overlapping (ix)of funds for the works being executed;
- the funds so released shall not be available for any re-(x) appropriation/diversion;
- the expenditure shall commensurate with the physical progress (xi) achieved;
- (xii) all video graphic/photographic evidence of works both shall be maintained.
- no expenditure shall be incurred against Revised Cost which has (xiii) not been approved by the Competent Authority.
