In continuation to Govt. Order No. 65-HUD of 2018 dated 23.02.2018, sanction is hereby accorded to the release of funds amounting to Rs. 12.00 Lacs (Rupees Twelve Lakh) only in favour of Director Building Centre Jammu/Srinagar (Rs. 6.00 Lakh each) under Housing Sector of State Capex Budget 2017-18 to be utilized for implementation of the Action Plan/Works Programme approved during current financial, thereby, aggregating total releases to the extent of Rs. 60.00 Lacs only during current financial year.

The Director, Finance H&UDD shall draw the funds in advance from Treasury through WDC Bill and place the same at the disposal of Director, Building centre Jammu /Kashmir immediately.

The release & subsequent utilization of funds is subject to the following conditions that:-

- (i) the release of funds does not confer the sanction to incur the expenditure which should be booked only after observing all codal formalities;
- (ii) the funds shall be utilized on those components of the schemes only which have been technically sanctioned and administratively approved by the Competent Authority;
- (iii) the funds so released shall not be available for any re-appropriation/diversion;
- (iv) the implementing agency shall ensure that there is no overlapping of funds for the works being executed;
- (v) the Director Finance/Joint Director (P&S) of the Deptt. Shall vouchsafe the utilization of funds as per codal procedure/guidelines;
- (vi) the implementing agency shall ensure that there is no overlapping of funds for the works being executed form any other source such as SDRF/State Plan/District Plan/CSS/BADP/Flagship programme or any other source;
- (vii) the Utilization Certificate of the amount is rendered to the concerned quarter within the stipulated time;
- (viii) the expenditure shall commensurate with the physical progress achieved;

- that all video graphic/photographic evidence of works both pre-execution and post (ix) execution shall be maintained;
- the physical and financial progress report shall be furnished to the Admn. Deptt. Well (x) in time, i.e. 5<sup>th</sup> of succeeding month;
- no expenditure shall be incurred against Revised Cost which has not been approved (xi) by the Competent Authority.
